Policy

1. Purpose of the Policy

1.1 This Policy provides guidance on the administration of the Commemorative Fund and establishes specific eligibility criteria and application requirements that provide clarity and certainty for Veterans' Affairs staff, **veterans** and the community.

2. Purpose of the Fund

- 2.1 The Commemorative Fund provides financial support to veterans wishing to revisit their place of **Qualifying Operational Service (QOS)**, to attend overseas or domestic commemorations related to their QOS (a Commemorative Travel Contribution from the Commemorative Fund).
- 2.2 It also provides financial support to New Zealand based projects which commemorate the service of New Zealand military personnel (a Commemorative Project Contribution from the Commemorative Fund).

3. Parameters of the Fund

3.1 This Policy applies only to applications made between 1 July 2024 and 30 June 2025, for travel between 1 July 2024 and 30 June 2025.

Commemorative Travel Contribution

- 3.2 Funding is provided to assist with veterans' travel costs to:
 - a. Attend overseas or domestic commemorations that are related to their QOS or
 - b. Return to their place of QOS.
- 3.3 The level of funding provided to each veteran is based on:
 - a. a lifetime maximum of \$2,000 for veterans who had used some of the available funding before 1 July 2016 but had not yet reached the maximum of \$2,000 at that time,
 - a. a lifetime maximum of \$2,500.00 for veterans who had not yet reached the maximum between 1 July 2016 and 30 June 2024,
 - b. international and domestic airfares including travel insurance, domestic connections including taxis, rail, buses, ferries and rental car hire (does not include fuel) and accommodation.
- 3.4 Veterans who reached the funding maximum before 1 July 2024 are ineligible for further funding.
- 3.5 Veterans who have eligibility under the Veterans' Support Act 2014 for the Travel Concession Payment, are not eligible for the commemorative travel contribution to attend a domestic commemoration in New Zealand; they are eligible for assistance towards accommodation costs in New Zealand up to a maximum of two nights.

Commemorative Project Contribution

- 3.6 Funding is provided to assist with costs for New Zealand based veterans and community groups planning New Zealand based projects to commemorate the QOS of New Zealand veterans.
- 3.7 The level of funding provided to projects is based on:
 - a. a maximum of \$5,000.00 per project,
 - b. associated costs less any other financial contributions already made to the project,
 - c. associated costs estimated based on quotes, with Veterans' Affairs providing funding prior to costs being incurred.
- 3.8 It is intended that Veterans' Affairs is a last call contributor: all costs beyond the amount Veterans' Affairs contirbutes must be covered by other contributors before a grant is paid. Applications should be made before a project's completion.
- 3.9 Funded projects are limited to the following:
 - a. reunion events in New Zealand for veterans of New Zealand Defence Force units, historical or present, that commemorate QOS,
 - b. plaques, cenotaphs and other memorials that commemorate the QOS of New Zealand veteran, and are open, free, and accessible to the general public,
 - c. publications that commemorate the QOS of New Zealand veterans,
 - d. education programmes, open to New Zealand students, that commemorate the QOS of New Zealand veterans.
 - e. support for the NZDF Invictus Games team in the form of team kit costs.
- In the case of reunions which meet criteria in 3.9-a., funding is provided on the basis of \$50.00 per veteran with QOS in attendance, to a maximum of \$5,000.00.

4. Eligibility Requirements

Travel

- 4.1 Eligibility is determined by the veteran having completed QOS, see the **List of Qualifying Service** (www.veteransaffairs.mil.nz/list-of-qos).
- 4.2 The veteran's intended travel must either include travel to the area of operations related to their QOS, or overseas travel to an official commemorative event related to their QOS, or travel to a domestic commemoration in New Zealand related to their QOS.
 - a. The specificity of this is limited to the country level, not regional or provincial level. For example, a veteran who served in Phuoc Tuy province, Viet Nam, does not need to return to Phuoc Tuy province to be eligible; they simply need to be travelling to Viet Nam.
 - b. Further, travel does not need to be to the original country, it can be to the successor state. QOS to Rhodesia qualifies for travel to Zimbabwe. QOS to

Yugoslavia qualifies for travel to Croatia, or any of the Balkan states that were a part of Yugoslavia at the time of QOS.

Project

- 4.3 Projects which meet the criteria set out in section 3.9 are required to have a high chance of successful completion. In order to establish this, the project should have local backing.
- 4.4 Reunions do not require local backing provided they meet the criteria in section 3.9a and 5.10.
- 4.5 For all other projects, the backing should be from local or regional council, businesses, schools, universities, libraries, non-government organisations, government or local lwi.
- 4.6 Where the project's total costs are below \$5,000.00, local backing can be non-financial. Where costs do exceed \$5,000.00, Veterans' Affairs requires that all costs in excess of \$5,000.00 are covered by other contributors.

5. Application Requirements

Commemorative Travel Contribution

- Veterans must complete the application form provided by Veterans' Affairs on the Veterans' Affairs website (www.veteransaffairs.mil.nz). This must be signed by the veteran, or a legal representative/guardian of the veteran.
- 5.2 Veterans must provide, with their application, evidence of destination of travel, such as destination specific itineraries, airline ticket receipts or equivalent evidence.
- 5.3 Veterans are required to provide evidence of a financial commitment to travel at the time of application. This could include paying all or part of the cost, placing a deposit, or an equivalent financial commitment to travel.
- 5.4 Veterans must provide bank-verified bank account details before payment can be made.

Commemorative Project Contribution

- 5.5 Applicants must complete the form provided by Veterans' Affairs on the Veterans' Affairs website (www.veteransaffairs.mil.nz). This must be signed by the nominated point of contact of the veteran/community group.
- 5.6 Applicants must provide evidence of costs associated with the project. This may be in the form of budgets, invoices, receipts and other supporting documents.
- 5.7 Applicants must provide evidence of local backing, including any pre-existing financial backing. This must be in the form of written communication from the relevant backer.
- 5.8 Any additional financial backing obtained after the application process has begun and before the project is completed must be disclosed to Veteran's Affairs.


- 5.9 Failure to disclose all costs and current financial backing may result in the application for funding being declined.
- 5.10 Applicants for reunion funding must provide the full names and service numbers of those veterans who attended the event.
 - a. Reunions can only be funded retrospectively.

6. Decision Reviews

- 6.1 If the veteran/applicant disagrees with a decision concerning eligibility for a commemorative travel contribution or a commemorative project contribution, they may request that the manager of the initial decision maker reviews the decision.
- 6.2 If the manager of the decision maker reviews the decision, then the outcome of the review will be considered the final decision and no further request for review will be accepted.



Glossary

member of the armed forces [Section 7 of the Veterans' Support Act]

Means a person who is or has been a member of the New Zealand armed force raised by the Governor-General on behalf of the Sovereign,—

- (a) whether in New Zealand or elsewhere; and
- (b) whether before or after the passing of this Act.

qualifying operational service

Section 8 of the Veterans' Support Act 2014

Means-

- (a) service on any deployment treated as a war or emergency for the purposes of the War Pensions Act 1954; or
- (b) service on any deployment declared to be operational service under section 9.

qualifying routine service [Section 8 of the Veterans' Support Act 2014]

Means service in the armed forces before 1 April 1974 that is not qualifying operational service.

qualifying service [Section 8 of the Veterans' Support Act 2014]

Means-

- (a) qualifying operational service; or
- (b) qualifying routine service.

veteran

Section 7 of the Veterans' Support Act 2014

Means-

- (a) a member of the armed forces who took part in qualifying operational service at the direction of the New Zealand Government; or
- (aa) a member of the armed forces who took part in qualifying routine service before 1 April 1974; or
- (b) a person-
 - (i) who has been:
 - (A) appointed as an employee of the Defence Force under section 61A of the Defence Act 1990; or
 - (B) seconded to the Defence Force with the permission of the Chief of Defence Force; and
 - (ii) who took part in qualifying operational service at the direction of the New Zealand Government; or
- (c) a person who, immediately before the commencement of Part 3 of this Act, is eligible for a pension under the following provisions of the War Pensions Act 1954:
 - (i) section 19 (but only if the person was a member of the forces):
 - (ii) section 55 or 56:
 - (iii) Parts 4 and 5.
