Briefings to incoming Ministers


We brief each incoming Minister about their portfolio. The briefing includes information on:

The Veterans' Support Act 2014 (VSA 2014) defines what support we can provide to those with Qualifying Service and their families and whānau. It guides our decision making and outlines what happens if people disagree with the decisions we make.
