#### When does this privacy statement apply?

This privacy statement applies to the personal information we collect from veterans and other claimants (the spouse, partner, children, dependants and those who provide non-professional support to veterans) who have coverage under the Veterans' Support Act 2014.

# What are the purposes for which we collect personal information, and why?

We collect personal information directly from you for the following purposes:

- To notify an individual of services that they may be eligible for and entitled to access.
- To enable an individual's identity and status as a veteran or other claimant to be verified.
- To assess or reassess the eligibility and entitlement of a veteran or other claimant for services.
- To facilitate rehabilitation and treatment of a veteran.
- To cleanse and update records of a veteran or other claimant.
- To assist in reviews and appeals against decisions regarding services.
- For the purposes set out in section 213 of the Act.

We also collect the information from other sources about you for the above nurnoses in accordance with an annroved

information sharing agreement (AISA) made under the Privacy Act 2020 or otherwise.

#### Who do we share your personal information with?

We may disclose your personal information to:

- A medical practitioner or treatment provider
- An agency that is a party to the AISA
- The Inland Revenue Department (IRD)
- a law enforcement agency or regulatory authority where required under law
- any other person authorised by applicable law.

#### How do we secure your information?

Your personal information is held in a controlled and secure environment. We use appropriate technical, organisational and administrative security measures to protect any information we hold from loss, misuse, and unauthorised access, disclosure, alteration and destruction.

Information you provide via user-submitted forms on our website is protected by AES-256 encryption.
